- Members should not disclose information, such as account user names and numbers, passwords, PINs, social security numbers, or account details, on Numerica's social media pages.
- Except for posting winner names as related to, or identified with, giveaways, contests, or other promotions, Numerica will not post identifiable member information on its social media pages.
- Numerica does not validate assertions or statements in comments on Numerica's social media pages. All statements and viewpoints expressed are strictly those of the commenter alone and do not constitute an official position of Numerica, unless posted for business purposes by an authorized representative of Numerica.
